The DD shall be drawn from any Nationalized/ Scheduled Bank in favour of "AO (Cash), O/o GM BA BSNL Jabalpur", **payable at Jabalpur.** Bank transaction acknowledgement will be emailed to email id- aocashjbp@gmail.com & gmjbp2@gmail.com the bidders before tender submission and also to be uploaded its scanned copy in e-portal site <https://etenders.gov.in/eprocure/app> by the bidders, failing it, bid will be cancelled.

- The tender documents shall be issued free of cost to MSE bidders on production of requisite proof in respect of valid certification from MSME/NSIC for the tendered item".
- The tender is invited through e-tendering process, hence physical copy of the tender document would not be available for sale.
- The bidding process will be accepted only through E-Tendering platform.**
- Once the bidder has submit his bid through E-Tender, it will be presumed that bidder has understand & accepted all the terms and condition of the tender and no correspondence at later stage will be entertained in this matters.

Note : The Tender document shall not be available for download on its submission / closing date.

EMD:- Payable to A.O. {Cash} O/o GM BA Jabalpur in the form of D.D / FDR issued by any schedule Bank in favour of AO (Cash), BSNL, O/o GM BA Jabalpur payable at Jabalpur.

Eligibility Conditions:

Bidder has to upload online (Self attested/attested by Gazetted Officer/ Notarized) /original copies of the following documents :

- i. Self attested Copy of registration of firms (i.e Shop/Gumasta Registration , sales tax registration, service tax registration or EPF registration or PWD registration or Registration in any Govt. body is valid for registration of firm.)
- ii. Authenticated copy of partnership deed in case of partnership firm.
- iii. Original "Power of Attorney" In case person other than the tenderer has signed the tender documents.
- iv. Self attested Copy of PAN Card / PAN Number. (In case of Partnership/Pvt. Ltd firm PAN No of firm is required, in case of Proprietorship firm PAN No of proprietor is to be enclosed).
- v. Self attested Copy of GST Registration No
- vi. Self attested Copy of EPF Registration (if not available, declaration should be given that it will be submitted at the time of agreement on award of work).
- vii. Self attested Copy of ESI Registration (if not available, declaration should be given that it will be submitted at the time of agreement on award of work).
- viii. Experience of having successfully completed same or similar work during Last 7 (Seven) Years ending the last day of month previous to the one in which applications are invited should be either of the following :-
 - (a) Similar nature of completed works in any three years costing not less than the amount equal to 40% of the estimated cost in each financial year during the last seven years. **OR**
 - (b) Similar nature of completed works in any two years costing not less than the amount equal to 60% of the estimated cost in each financial year during the last seven years. **OR**
 - (c) Similar nature of completed works in any one year costing not less than the amount equal to 80% of the estimated cost in each financial year during the last seven years.

Similar works includes the work related to House Keeping, BTS Up-Keeping, Maintenance of horticulture, Caretaking and Maintenance work of Inspection Quarters/Guest Houses/Rest Houses of BSNL/MTNL/DOT or Central Govt. or State Govt. or Through their PSUs.

The EXPERIENCE CERTIFICATE should be issued by the Divisional Engineering officer of BSNL/ MTNL/ or similar certificate issued by competent authority of Central Govt./ State Govt./ Govt. under taking & semi Govt. Similar work also include the satisfactory work done in Govt. Hospitals, National/Scheduled Banks, Govt. Hotels, Any Govt.(state or central) Organization/Institution which is outsourcing such services, anywhere in India and the EXPERIENCE CERTIFICATE submitted must be on the letter head of respective organization by competent authority.

NOTE:- EXPERIENCE CERTIFICATE means the certificate having financial year wise breakup of amount of work/supply done satisfactory by contractor and Financial year means 1st April to 31st March. Only the financial year wise EXPERIENCE CERTIFICATE with mentioned amount will be accepted regarding experience. The Work Order/Purchase Order will not be accepted.

Note :- (Any three year means) e.g. Y1, Y2,Y7 is financial year 1, 2,.....7.If any bidder completed work costing in Y1 40%, in Y3 40% and in Y7 is 40% is eligible (Similar suitable combination may be considered for eligibility during the seven year block.

- ix. Self-declaration regarding no near relative is employed in BSNL.(A)
- x. Self-decl. that the bidder/firm has not been barred from taking part in tender any where in BSNL.(B)
- xi. Self Declaration- C to G as attached in Section-III of tender document
- xii. Valid labour license for any of ongoing work and if not available at the time of bid submission or there are no ongoing works then enclose a declaration letter mentioning that labour license will be obtained on award of contract within stipulated time.
- xiii. In case bidder happens to be MSME bidders, the valid documentary evidence for the same shall be uploaded.
- xiv. The Corrigendum is the part of tender document and is mandatory to upload, if any.
- xvi. The bidders (Small Scale Units) who are registered with (National Small Scale Industries Corporation) NSIC / MSME under Single Point Registration Scheme are exempted upto the amount equal to their monetary limit. In case of bidder, having monetary limit as no limit the exemption will be limited to Rs.1.5 Lac (Rupees One Lac fifty thousand) only as per the existing policy of BSNL. A proof regarding current registration with NSIC / MSME for the Tendered Item will have to be attached along with the bid.

The General Manager, BA Jabalpur reserves the right to accept or reject one, more than one or all the tenders in part or wholly without assigning any reason. He also reserves the right to terminate the contract at any time giving one month's notice in writing without assigning any reason.

Tender can be short closed before due time by BSNL due to any technology change / administrative or business reason / umbrella contract finalized and implemented by higher authority or office without any kind of claim by contractor.
